

Meeting Summary for Special Meeting of the Riverbend BOD

The meeting Quick recap

Riverbend, Tamika, and Sherry attended a meeting with the possibility of a representative from the New York Attorney General's office joining to observe and ask questions. Serious allegations were raised against Taren Payne, a board member of Riverbend Housing, including an altercation with management staff, unauthorized changes to company passwords, and deletion of company property. Difficulties in re-entering a Zoom account and the permanent deletion of some meeting recordings were also reported, with Taren requesting evidence to substantiate these claims.

Next steps

Riverbend to provide Zoom documentation showing the IP address and time of the deletion of meeting recordings.

Princess to analyze the Zoom documentation to identify the device responsible for deleting the information.

Board members to review and prepare evidence supporting the allegations against Taren Payne for the upcoming shareholders meeting in 10 days.

Summary

Awaiting Directors and NY Attorney

Riverbend, Tamika, and Sherry attend a meeting. They wait for other directors to join before starting. A message informs them that a representative from the New York Attorney General's office may join to observe and ask questions. They acknowledge this and discuss whether another person named Princess has joined the meeting yet.

New York AG's Office Attendance

In the meeting, Riverbend and Tamika discussed the potential attendance of a representative from the New York Attorney General's office at a future meeting. Taren clarified that the representative had requested access to the meeting and had been forwarded the meeting invite. Tamika emphasized that the meeting was not for answering questions, but for a vote. Taren expressed concerns about the board's handling of the situation and the potential legal implications of refusing the representative's request for documentation. Tamika reiterated that the meeting was not for answering questions and that the representative could join the next meeting in 10 days.

Addressing Allegations Against Taren

The meeting was called by Tamika to address serious allegations against Taren Payne, a board member of Riverbend Housing. The allegations included an altercation with management staff, unauthorized changes to company passwords, and deletion of company property. Tamika emphasized that these actions violated the board's policies and posed a significant threat to Riverbend's operations, security, and governance. Taren questioned the evidence supporting these allegations, but no evidence was provided during the meeting.

Riverbend and Princess did not have anything to add to the charges. The conversation ended without a resolution on the allegations against Taren.

Zoom Account Issues and Deleted Recordings

Riverbend reported difficulties in re-entering a Zoom account due to added authentication, which led to a 48-hour delay. Riverbend also discovered that some meeting recordings from 2024 and possibly 2023 had been permanently deleted. Taren requested evidence to substantiate these claims, while Princess asked about documentation from Zoom regarding the deletion. Riverbend confirmed that Zoom could provide the IP address of the time of the deletion.
